2011-12 FEE SCHEDULE AND AGREEMENT

Know all by these Presents:

That, for consideration of my daughter, _____'s participation in the *Thunder Volleyball Texas Club* program for the 2011-12 season, beginning November 2011, I agree to pay the **full** sum below which corresponds to my daughter's team, (_____) to participate on said team. Payment can be made in full, or for my convenience, in the following manner. All payments will be supplied to *Thunder Texas VBC* prior to the first practice of each month to participate, by check, money order or cash. If a check deposited on or after the written date is not honored, I will pay all fees incurred at my banking establishment and by *Thunder Volleyball Texas*, to insure my child's continued participation in the program. PayPal payments, online at www.ttv.net, will incur a 4% convenience fee; and payments are due prior to the first practice of the month. A valid credit card number with authorization to charge late payments, must be on file with *Thunder Volleyball Texas* prior to the beginning of the season. I will continue to make monthly payments, or make funds available for the amount, even, **if for any reason**, my daughter, _____ does not continue for the entire 2011-12 USAV Club Season. Team budgets are calculated based on **10-12** team members depending on the level of the said team; if a team is formed with less, individual fees will reflect total budget of that team. Developmental group rates are based on 12-14 athletes per court (no uniforms included, only t-shirt). If the intention to meet financial responsibilities to *Texas Thunder Volleyball* is through **fundraisers** or a **subsidized position with the club**, all money is to be paid in full by 02-15-2012, as ongoing fundraisers are available with TTVC. _____(Parents' Initials)

Upon commitment to Texas Thunder Volleyball, your commitment to the Annual Golf Tournament Fundraiser of obtaining either one foursome for golf @ \$300/team, 3 hole sponsors @ \$100 each, per athlete, is expected and understood. This fundraiser is the club's efforts to keep season fees from increasing. _____(Signature)

That, in the event that I do not make an installment payment, my child will be suspended from the program until all such payments in arrears are made, but that such suspension or my child's failure to participate in the program does not relieve me from the obligation hereunder. That, in the event that my child is suspended for more than one (1) month for non-payment, then the entire amount outstanding will become immediately due and payable on demand. That, I waive notice, presentment and protest for the collection of any and all outstanding debts under this agreement; and shall bear all costs for the collection of the same.

***Fees Listed Below cover the following:**

Practice Times at one of three locations, three times per week

PRACTICE TIMES: three times per week for *Local, Regional, American & National*;

Practice times will be a combination of Mondays & Wednesdays; Tuesday & Thursdays; or Mondays & Thursdays; All teams practice on Sundays at the Gym, when there is no tournament scheduled. Older teams could possibly practice three week-nights, without a Sunday practice to allow for unofficial/official visits for recruiting purposes.

Note: weekend tournament negates Sunday practice

LEVELS OF TEAM

VOLLEYTOTS: (season training from January to March, 12 weeks, once per week); Fee of \$150 for 12 weeks.

11's & 12's: Thunder 11's will participate in 4 tournaments with 3 practices per week; while Thunder 12's will participate in 7-8 tournaments with 3 practices per week.

LOCAL: 10 total area tournaments;

REGIONAL: 2 regional tournaments & 7-8 area tournaments;

AMERICAN: 4-6 area tournaments, 2-3 Regional tournaments & 1 National out-of-state tournament.

NATIONAL: 4-6 area tournaments, 2-3 regional tournaments & 2 National out-of-state tournaments (17 & 18's teams). Out-of-state NATIONAL or AMERICAN tournament fee includes hotel rooms for athletes & team van at location. Airfares are not included in fees; but Thunder makes groups bookings for athletes & accompanying family members, which are the sole responsibility of person traveling.

Coaches Fees: All practice and tournament coach's fees, travel and accommodations, are included.

Hotels & transportation to & from tournament is sole responsibility of athlete and her family, unless group option is elected. Group option will include ground transportation & hotels @ rate of \$50 per day for a minimum of 6 athletes.

Additional Tournaments Fees: Once tournament schedule is announced, additional fees will be due prior to deadline (TBD) for added tournament or that tournament will be cancelled for that team. Additional tournament fees will be \$100 per athlete for Regional Tournament (when teams qualify for Tour of Texas, additional tournaments are added to schedule), and \$500 per athlete for National (includes hotel & van, but not airfare for out-of-state). This applies for extended season tournaments such as Southwest Nationals, Volleyball Festival, AAU's. _____ (Initials)

For teams which qualify for Junior Nationals or those which extend their season to AAU Championships, estimates per athlete, for participation, will be assessed upon qualification.

Uniforms are additional cost as per uniform order form (should be appropriate for a minimum of two club seasons).
